Thank you for taking the time to contact me regarding the Canadian oil sands.

The Canadian oil sands are not a new fuel resource, as Canada has been extracting oil from this source for more than fifty years. Moreover, the new form of extraction, SAG-D, is deep mined rather than open cast and therefore causes little environmental footprint.
